

THE “Connecting Biz Views” PRIVACY POLICY

Your privacy is important to ABN Impact HK Limited (referred to as "we" or "us" in this policy) and the purpose of this policy is to tell you what personal information we collect about you during your participation in “Connecting Biz Views” and how we use it.

You are free to choose whether or not to participate in a survey, free to choose not to answer any specific questions and free to discontinue participation at any time.

Your individual responses will be kept confidential and never linked to your personally identifiable information without your express permission.

ACCEPTANCE OF TERMS OF THIS PRIVACY POLICY AND CONSENT TO THE USE OF YOUR PERSONAL INFORMATION

By participating in “Connecting Biz Views” or by submitting personal information to “Connecting Biz Views” you agree that we may collect, use and disclose such personal information in accordance with this Privacy Policy, and as permitted or required by law. We encourage you to read this Privacy Policy, which has more detailed information about, amongst other things, retention and access of your personal information and certain limited permitted uses of your personal information by third parties. If you do not agree to the terms of this Privacy Policy, please do not participate in “Connecting Biz Views”.

Personal information

"Personally identifiable information" or "personal information" means any information about you that directly identifies you, such as your name, telephone number, e-mail address, information you provide in the profiling questionnaire. During your participation in “Connecting Biz Views”, we collect personally identifiable information when provided by you in online forums or survey responses.

Personally identifiable information does not include information used in its aggregate form such that it is impossible to identify personally identifiable information. Data that you provide during your participation in “Connecting Biz Views” that is not linked in any way to your personally identifiable information and is aggregated with other participant data is not considered to be personally identifiable information.

What personal information do we collect?

The “Connecting Biz Views” will not collect any personally identifiable information about you, unless you voluntarily choose to provide it to us (e.g., by completing the profiling questionnaire or participating in surveys). If you do not want your personal information collected, please do not submit it to us.

We will collect information about you when you:

- register to become a member of the Connecting Biz Views community;
- complete activities on the Connecting Biz Views website such as online discussions, focus groups, mini polls or surveys;
- email our technical support or submit suggestions about the Connecting Biz Views website;
- use the Connecting Biz Views website; or

- perform other activities, such as completing our initial profiling questionnaire.

We may collect and process the following data about you:

- your contact details;
- your responses to questionnaires;
- comments made in online discussions;
- photos or videos uploaded to the Connecting Biz Views website or emailed as part of a specific activity;
- comments you make in emails;

How do we use your personal information?

We use the personal information you provide through your participation in “Connecting Biz Views” only to conduct market research on behalf of HSBC (as defined below) but such information will never be used in any way to target you for particular marketing or solicitation activities. We will process and use your personal information in order to respond to your feedback – like responding to problems and improving our services

Examples of how we may use your personal information:

- To send you email invites to relevant research activities.
- To send you prizes or incentives should you win or be eligible for one.
- To identify who to send certain research activities to in order that you are invited to those most relevant to you.
- To respond to any queries you email to us with regards to the Connecting Biz Views website or specific research activities.
- To conduct research and analysis on behalf of HSBC (as defined below)

Otherwise, your information and opinions are used in non-personally identifiable aggregate form with other participant data to conduct both quantitative and qualitative market research, e.g. to create research reports, company presentations, relevant content for the Connecting Biz Views website and newsletter to share with other participants of Connecting Biz Views etc.

Any personally identifiable information you provide us outside of your participation in “Connecting Biz Views”, such as the information you provided when you became a “Connecting Biz Views” subscriber, will be used only for the purposes set out in this Privacy Policy.

By submitting your comments, photos, and videos, you agree that we are able to use these in company presentations and reports. We will not disclose any of your personal contact details in doing so. We may also share some of this on the Connecting Biz Views website; again we will not disclose your personal contact details.

The Hongkong and Shanghai Banking Corporation Limited ("HSBC"), as the sponsor of "Connecting Biz Views" will have full access to, and we may pass on to HSBC, all the materials on "Connecting Biz Views" including your opinions, comments and feedback and any personal information you provided voluntarily. All these will only be used for market research purpose including creating research report and company presentations, creating relevant content for the "Connecting Biz Views" website and for sharing with other members of the HSBC group etc., but not for direct marketing and solicitation activities.

You can choose a user name when participate in the forum discussion. If you would prefer not to show your name to other Connecting Biz Views members, please choose a made up name.

We will remove all survey data and personal information you provide to us 3 months after the completion of this project.

What can you do if you want to limit the use to which we put your personal information?

You are always free to choose whether or not to participate in a survey, free to choose not to answer any specific questions and free to discontinue participation in "Connecting Biz Views" at any time. You can refuse to consent to our collection, use or disclosure of personal information about you for "Connecting Biz Views". You may also withdraw your consent to any further collection, use or disclosure of information about you in respect of "Connecting Biz Views" at any time by giving us reasonable notice and subject to legal and contractual requirements. However, such withdrawal of consent will mean you can no longer participate in "Connecting Biz Views".
