

User Agreement

The following User Agreement ("Agreement") governs the use of the www.connectingbizviews.com.hk site ("Connecting Biz Views"), including without limitation participation in its online surveys, forums, live chats, and all other areas (except to the extent stated otherwise on a specific page) as provided by ABN Impact HK Limited ("Service Provider," "we", "us" or "our"), through "Connecting Biz Views". Please read the terms contained in this Agreement carefully. You can access this Agreement any time at www.connectingbizviews.com.hk . **Your use of and/or registration on any aspect of "Connecting Biz Views" will constitute your agreement to comply with these terms.** If you do not agree with these terms, please do not use "Connecting Biz Views". In addition to reviewing this Agreement, please read our Privacy Policy. Your use of "Connecting Biz Views" constitutes agreement to its terms and conditions as well. The Agreement may be modified from time to time; the date of the most recent revisions will appear on this page, so check back often. Continued access of "Connecting Biz Views" by you will constitute your acceptance of any changes or revisions to the Agreement. Your failure to follow these terms, whether listed below or posted in "Connecting Biz Views", may result in suspension or termination of your access to "Connecting Biz Views", without notice, in addition to the Service Provider's other remedies.

I. Registration and Account Creation

1. REGISTRATION INFORMATION

The Service Provider may at times require that you register and/or set up an account to use certain portions of "Connecting Biz Views", or "Connecting Biz Views" as a whole. In order to do so, you may be provided, or required to choose, a password, User ID, and/or provide other registration information (collectively, "Registration Information"). 使用協議
